Vehicle Parking: One (1) tow vehicle is included with your entry. Any additional vehicles are \$15/day to park in La Paz County Park. DO NOT BLOCK PITS!! Additional vehicle fee is payable at registration and limited to two (2) additional vehicles per entry.

Course Info: Jr. Hydroplane & Sportsman Limited Stock Outboard Classes: two (2) 3 lap heats/day. Formula Lights: three (3) 10 laps qualifiers and one (1) 15 or 20 lap final (TBD) on an approx. 7/8-mile course. All others: Approx. 1-1/4-mile course; Sportsman Extreme, GPS100, Crackerbox, Unblown Flat, K Racing Runabout, Comp Jets, Classic Endurance: two (2) 4 laps heats/day. Formula 1 TBD (based on attendance).

Start Type: Clock/Flag/Le Mans

Safety / Rescue: WMI Rescue

Entry Fees: All CLASSES except Jr. Hydroplane & Sportsman Limited Outboard classes, \$125/day or \$250 Weekend Fee. 2nd class fee is \$100/day. Late Fee is \$50/class. Jr. Hydroplane \$50/day, Sportsman Limited Stock Outboard \$80/day 1st class, \$50/day 2nd class, \$30/day 3rd class.
