Regatta: 2021 SCSC Outboard National Championships/Lake Ming Shoot Out

Location: Bakersfield, CA – Lake Ming

Directions: Interstate 99 (North or South) exit 178 East. Turn left on Alfred Harrell Hwy to Lake Ming Rd. Make right and follow to lake.

Accommodations: Host Hotel: Courtyard by Marriott Bakersfield, 3601 Marriott Dr., Bakersfield, CA 93308 (661) 324-6660 must use “Southern California Speedboat Club Racer” to get racer rate of \$89/night +tax. Rooms are limited. **Racer rate is available until September 10th, then goes back up to the regular rate.** 1st come, 1st served. RV Camping: \$50/vehicle/day at Park Rangers discretion. Camping fees to be paid at registration check in. Money will be collected on-site. *Note:* If enclosed race trailer/toy hauler has sleeping area you will be charged as a camper whether you stay in it or not per Kern County Parks Dept.

Course Info: Jr. Hydroplane & Sportsman Limited Stock Outboard Classes: two (2) 3 lap heats/day; Formula Lights: three (3) 10 laps qualifiers and one (1) 15 or 20 lap final (TBD) on an approx. 7/8 mile course. All others: Approx. 1-1/4 mile course; Sportsman Extreme, GPS100, Crackerbox, Unblown Flat, K Racing Runabout Pro, Comp Jet: either two (2) 4 lap heats/day or three (3) 3 lap qualifiers and one (1) 4 lap final/day. GN: two (2) 10 lap heats on Saturday and 20 lap final on Sunday. Classic Endurance: two (2) 4 laps heats/day. Mod VP Classic/Ski: two (2) 4 or 5 lap heats/day (TBD based on attendance). Formula 1 TBD (based on attendance).

Start Type: Clock/Flag/Le Mans

Safety / Rescue: WMI Rescue

SCSC National Championships: All Outboard Classes. *National Championships are based on overall cumulative points from the weekend.*

Entry Fees: All CLASSES except Jr. Hydroplane & Sportsman Limited Outboard classes, \$125/day or \$250 Weekend Fee. 2nd class fee is \$100/day. Late Fee is \$50/class. Jr. Hydroplane \$50/day, Sportsman Limited Stock Outboard \$80/day 1st class, \$50/day 2nd class, \$30/day 3rd class.
