**Course and Heat Info:** Approx. 1-1/4-mile course. Jr. Hydroplane & Sportsman Limited Stock Outboard Classes: two (2) 3 lap heats/day; Sportsman Extreme, GPS100, Crackerbox, Unblown Flat, Comp Jets, Classic Endurance: two (2) 4 lap heats/day; GN: two (2) 10 lap qualifiers and one (1) 20 lap final; K Racing Runabout: time trials and two (2) 3 lap heats/day. Formula 1, Tri Hull: TBD (based on attendance). Formula Lights: three (3) 10 laps qualifiers and one (1) 15 or 20 lap final (TBD) on an approx. 7/8-mile course.

- **All CLASSES** (except Jr. Hydroplane & Sportsman Limited Outboard classes) \$300 weekend fee (\$150/day); 2nd class \$250 weekend fee (\$125/day); 3<sup>rd</sup> class \$210 weekend fee (\$105/day)
- **Jr. Hydroplane** \$130 weekend fee (\$65/day)
- **Sportsman Limited Stock Outboard** \$210 weekend fee (\$105/day); 2<sup>nd</sup> class \$150 weekend fee (\$75/day); 3<sup>rd</sup> class \$110 weekend fee (\$55/day)
- **Late Fee** is \$75/entry.
